- a) The Tournament Director reserves the right to change the tournament format at any time due to weather or any unforeseen circumstances. No rain date is planned.
- b) The tournament fee for this four (4) game format tournament is \$350.00 (U.S). The planned format is for three games of pool play with all teams advancing to single elimination tournament. All teams may have to play Friday, however we will give special consideration to out of area teams when possible.
- c) All teams must be sanctioned by NSA and present proof of insurance prior to play. Contact NSA's Lisa Simpson at (330) 825-7010 or by e-mail at lsimpson@neo.rr.com for information. All teams must check in to have these items verified at the Ohio Sports Park Complex before the team's first game.
- d) Map, directions, lodging and attraction information can be found at www.northcoastspirit.com or www.ohiosportspark.com
- e) In case of rain, managers are responsible for contacting the tournament director to confirm game times and any additional rescheduling information.
- f) Except for \$75.00, registration fees will be refunded if notified by May 22. After May 22, there will be no refunds. No refunds will be made for any unplayed games. In the event the tournament is completely rained out, monies will be refunded on a prorated basis after deducting expenses incurred.
- g) Berths to the NSA "A" World Series and the NSA "B" World Series will be awarded in each age bracket per the NSA guidelines.
- h) Registration is limited to a maximum of 60 teams on a First Come, First Served basis.
- i) Team trophies and individual awards will be given to the 1st and 2nd place teams in each age bracket.
- j) NSA Rules will govern all play. Tie Breakers for seeding to the Single Elimination Bracket of the tournament are (in order): Won-Loss Record; Head to Head Results; Runs Allowed, Run Differential; and then Coin Toss.
- k) A coin toss will determine the home team for each game and the home team will be responsible for keeping the official scorebook.
- l) Scheduled game time is forfeit time (NO GRACE PERIOD). All teams must be at the field and prepared to play 30 minutes before scheduled game time.
- m) All games except for the Championships will be 7 innings or less with no new inning starting after 1:10 minutes. Championship games will have no time limit. If the score is tied at the end of regulation play, the Ohio NSA International tiebreaker rules will determine the winner.
- n) A mercy rule will apply to all games as outlined by the Ohio NSA. Coaches are responsible for knowing the team's schedule and being aware of any changes.
- o) There will be a \$75.00 "rules" protest fee, payable in cash, at the time of the protest. The fee will be refunded to the protesting team if the protest is ruled in their favor. No protests will be allowed for judgment calls.
- p) Ohio Sports Park admission fee for this tournament is \$5.00 per person per day for those patrons over 12. All paid admissions will receive a token that may be used at the concession stand for a 20ounce beverage of your choice. Three Coaches passes will be given to each team. Players in uniform will be admitted free.
- q) North Coast Spirit/Ohio Sports Park of North Ridgeville, and the NSA will not be held responsible for any accident or injury during this tournament.
- r) All parents, fans and players are to OBEY any parking regulations posted or instructions given or they will be subject to having their vehicle towed. Ohio Sports Park does not permit pets at the complex.
- s) No warm-ups allowed on playing fields. Hitting balls against backstops and fences is not permitted.
- t) Concessions will be available. Seating around diamonds is limited, bring chairs.
- u) WEATHER AND ITS EFFECT ON THE FIELDS IS BEYOND THE CONTROL OF THE NSA & THE TOURNAMENT COMMITTEE.
